HOSPITAL OPERATIONS AND PUBLIC HEALTH OUTREACH PROGRAMS: 1. Subsidy of KIDA Hospital operations applied to salaries and benefits of 50 healthcare workers: \$131,833. KIDA Hospital provides 24-hour inpatient care, labor and delivery, C-sections as needed, minor surgery, outpatient care including HIV testing, immunizations, prenatal care and family planning services. In 2019 more than 25,000 people accessed the services. 2. Subsidy for community outreach: \$7,376. HIV Prevention Education through monthly drama live shows, care and treatment of 490 HIV positive clients through regular home visiting, and village health education workshops. 5 KIDA Hospital staff members and healthcare volunteers visit villages twice monthly to educate 10 village groups in HIV prevention, better sanitation, improved pregnancy outcomes and perform HIV tests and vaccinations as needed.

ECONOMIC EMPOWERMENT PROGRAMS FOR THE POOR: 1. Orphan and vulnerable children education costs: \$33,022 for 91 students supported with school fees, supplies and counseling in all levels of education. 18 students attend boarding school. Of the 91 students 40 were primary level, 40 were secondary level, 9 were tertiary level and 2 attended an off-site vocational program. 2. Vocational school for youth: \$2,770 subsidy for teacher salaries and supplies. 45 were new students in 2019. Classes are offered in brick building, carpentry, tailoring and hairdressing. Goal is for each student to learn a marketable trade and earn income. Courses run for 14 months.
