HOSPITAL OPERATIONS AND PUBLIC HEALTH OUTREACH PROGRAMS: 1.Subsidy of KIDA Hospital operations applied to salaries and benefits of 37 healthcare workers: \$132,562. KIDA Hospital provides 24-hour inpatient care, labor and delivery, C-sections as needed, minor surgery, outpatient care including HIV testing, immunizations, prenatal care and family planning services. In 2020 221,610 people accessed the services. 2.Subsidy for community outreach: \$8,692. HIV Prevention Education through monthly drama live shows, care and treatment of 510 HIV positive clients through regular home visiting, and village health education workshops. 5 KIDA Hospital staff members and healthcare volunteers visit villages twice monthly to educate 10 village groups in HIV prevention, better sanitation, improved pregnancy outcomes and perform HIV tests and vaccinations as needed.

ECONOMIC EMPOWERMENT PROGRAMS FOR THE POOR: 1. Orphan and vulnerable children education costs: \$25,976 for 90 students supported with school fees, supplies, and counseling when school was in session. Some supplies purchased before the Covid lockdown were not given out in 2020. During the Covid 19 lockdown, 67 students (39 girls and 28 boys) were visited and provided with printed materials to study at home. In addition, KIDA staff held classes in basket weaving and leather crafts so that families could produce marketable products to generate some income during the lockdown. 2. Vocational school for youth: Students pay small tuition that partly covers the cost for teacher salaries and supplies. In 2020 some fees were paid and then the government ordered a lockdown due to Covid 19, leaving a balance of \$667 for the resumption of classes. 50 were new students in 2020. Classes are offered in brick building, carpentry, tailoring, and hairdressing. Goal is for each student to learn a marketable trade and earn income. Courses normally run for 14 months.
