IN 2021 THERE WERE 2,258 INPATIENT ADMISSIONS, 4,469 OUTPATIENT VISITS, 444 BABIES DELIVERED, 1009 FAMILY PLANNING VISITS, 1,672 WOMEN RECEIVED PRENATAL CARE, 936 HIV TESTS WERE PERFORMED, 937 VIRAL LOAD TESTS WERE DONE, 177 SURGICAL OPERATIONS TOOK PLACE AND 9,547 CHILDREN WERE VACCINATED. 2. SUBSIDY FOR COMMUNITY OUTREACH: \$4,768.
