KIDA HOSPITAL PROVIDES 24-HOUR INPATIENT CARE, LABOR AND DELIVERY, C-SECTIONS AS NEEDED, MINOR SURGERY, OUTPATIENT CARE INCLUDING HIV TESTING, IMMUNIZATIONS, PRENATAL CARE AND FAMILY PLANNING SERVICES.
